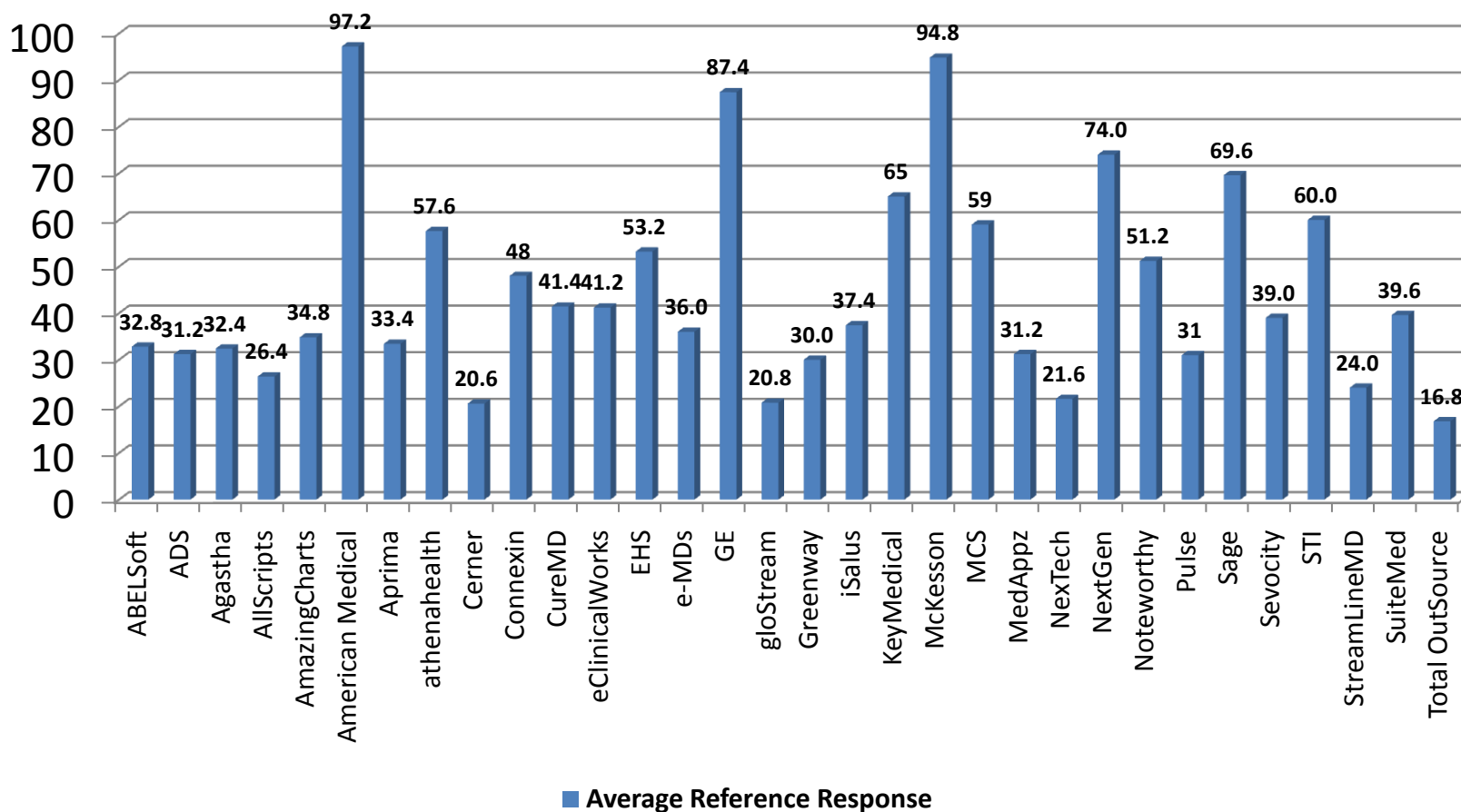

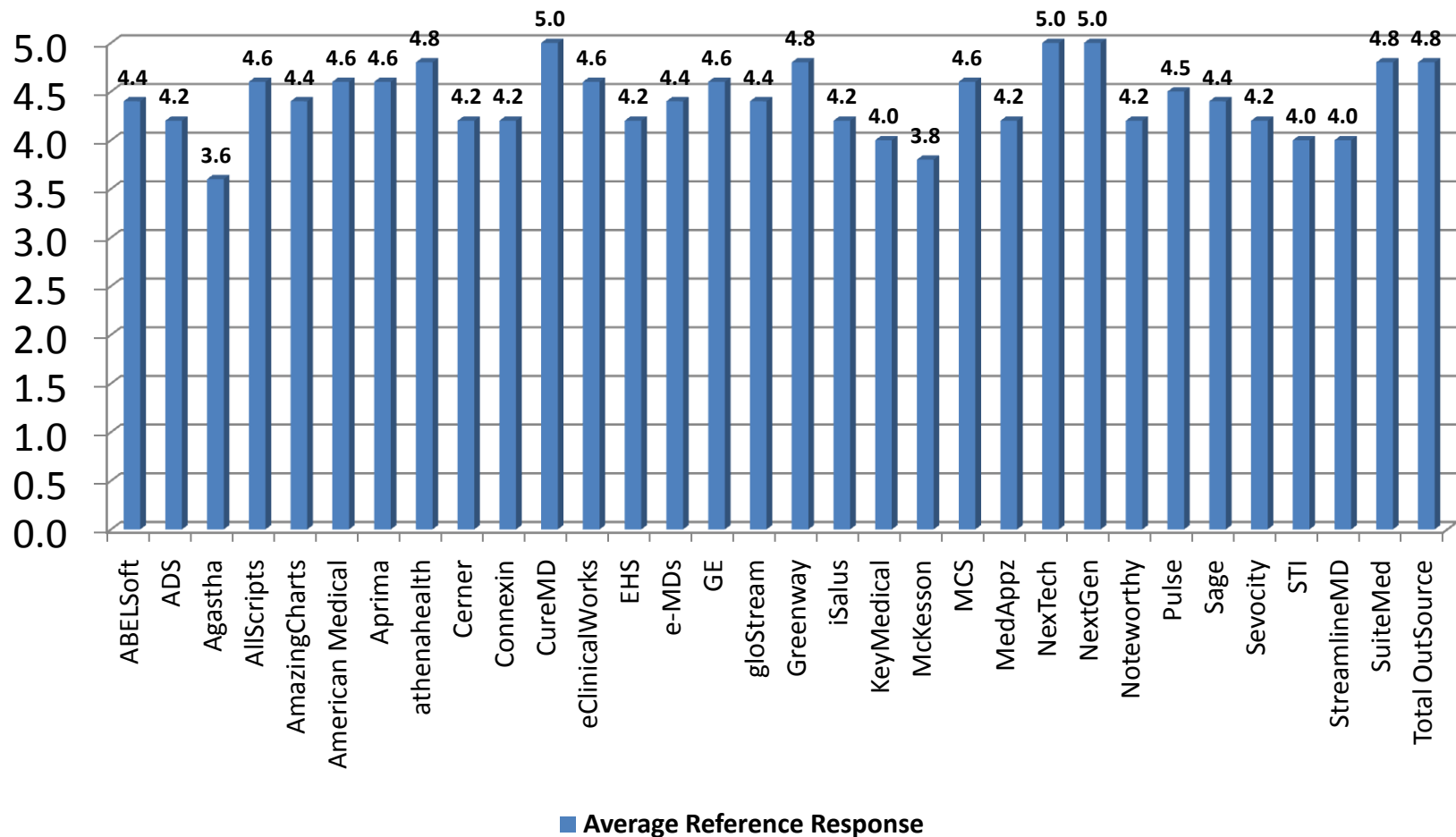

Average Months



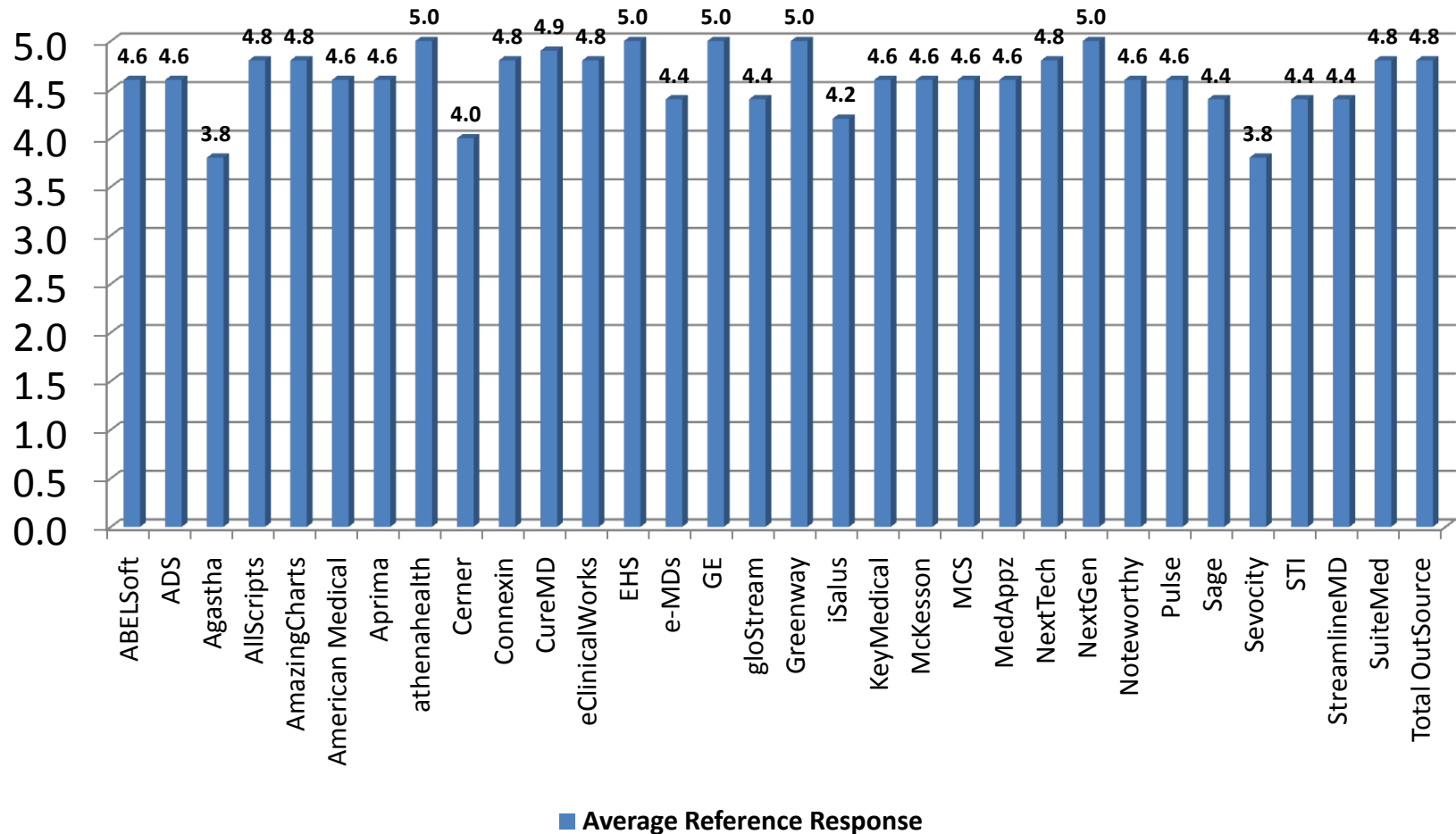
How would you rate the benefit of the EHR for your practice?

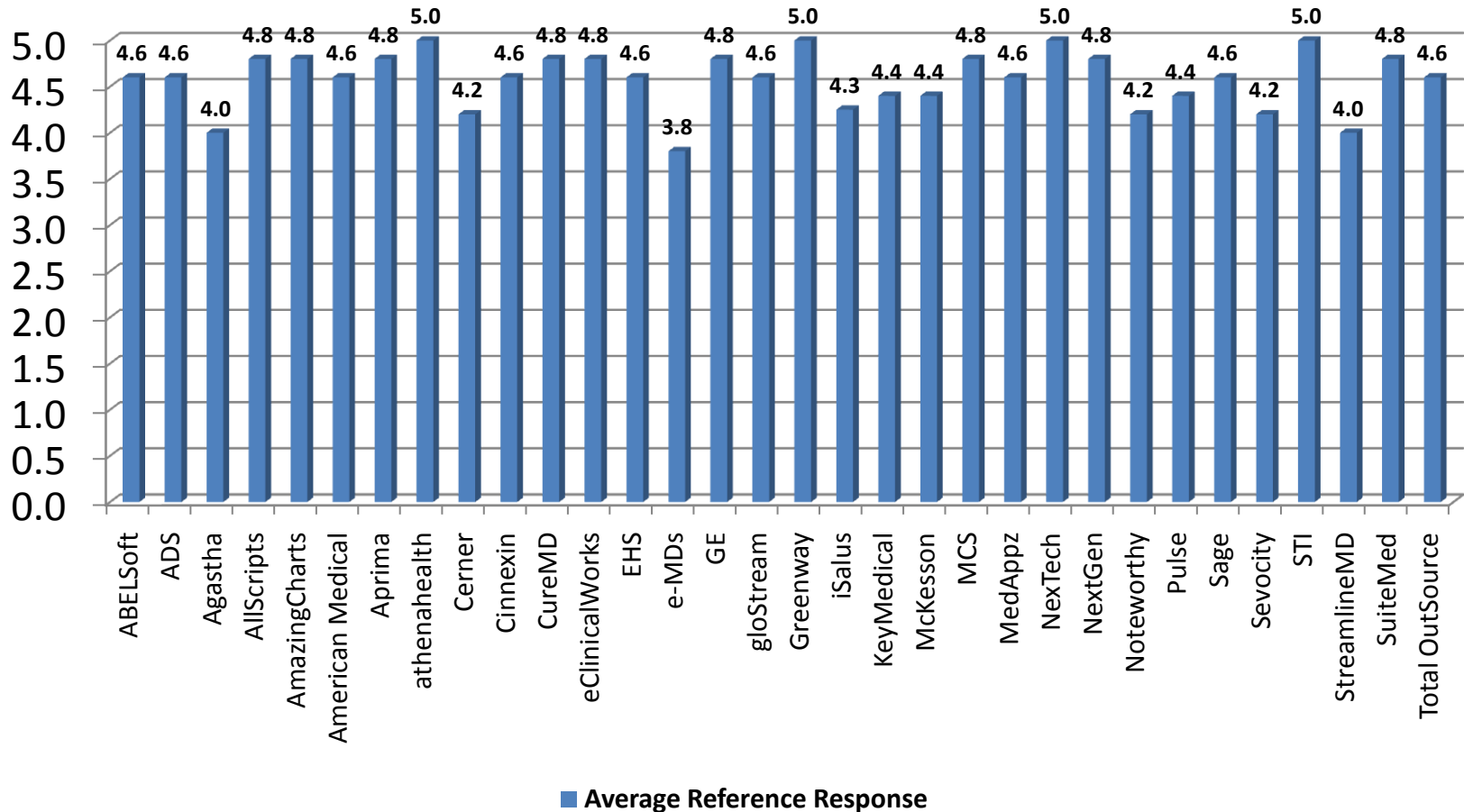
How would you rate your satisfaction with the EHRs ability to review patient charts?

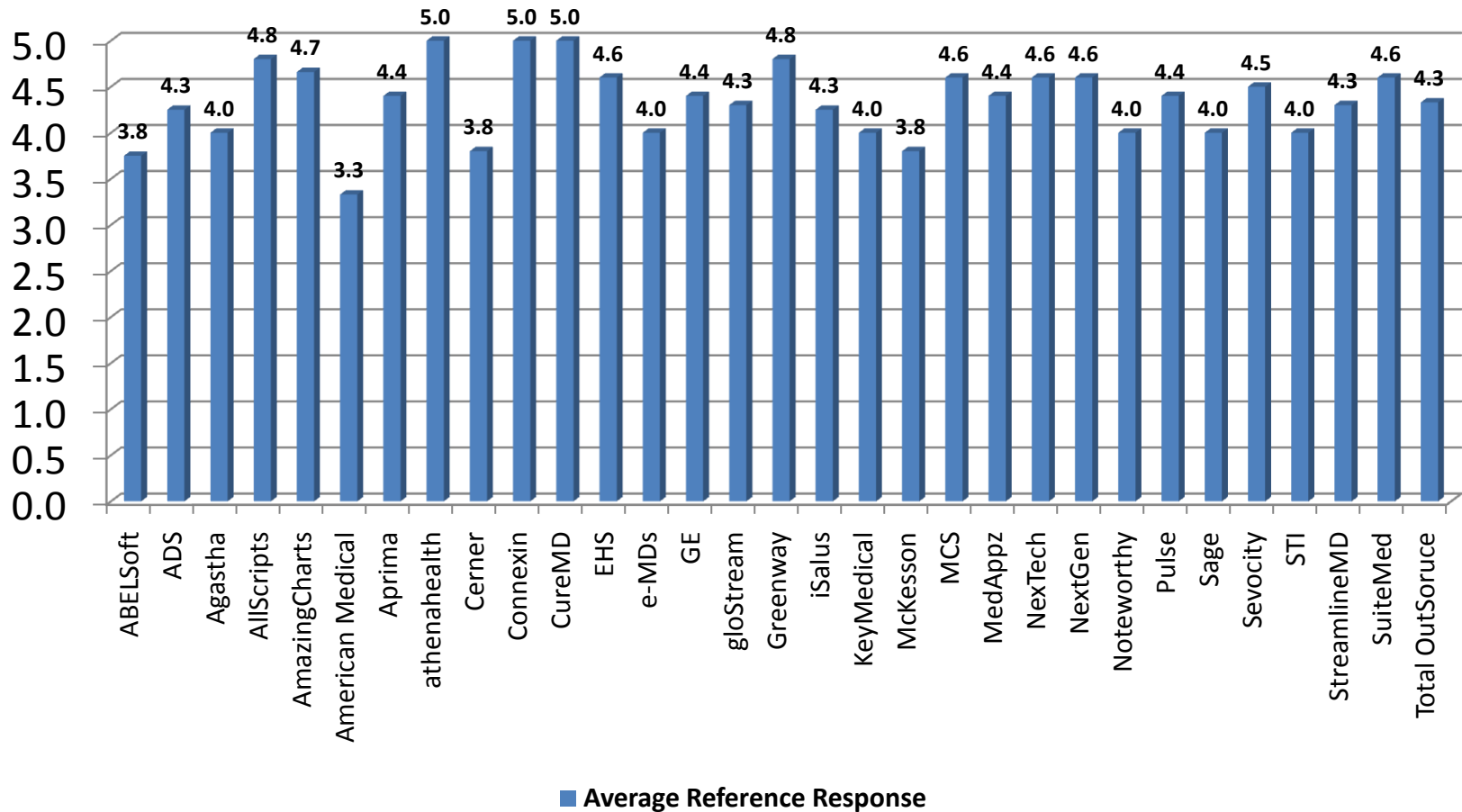
How would you rate your satisfaction with the EHRs ability to update and document in patient charts?

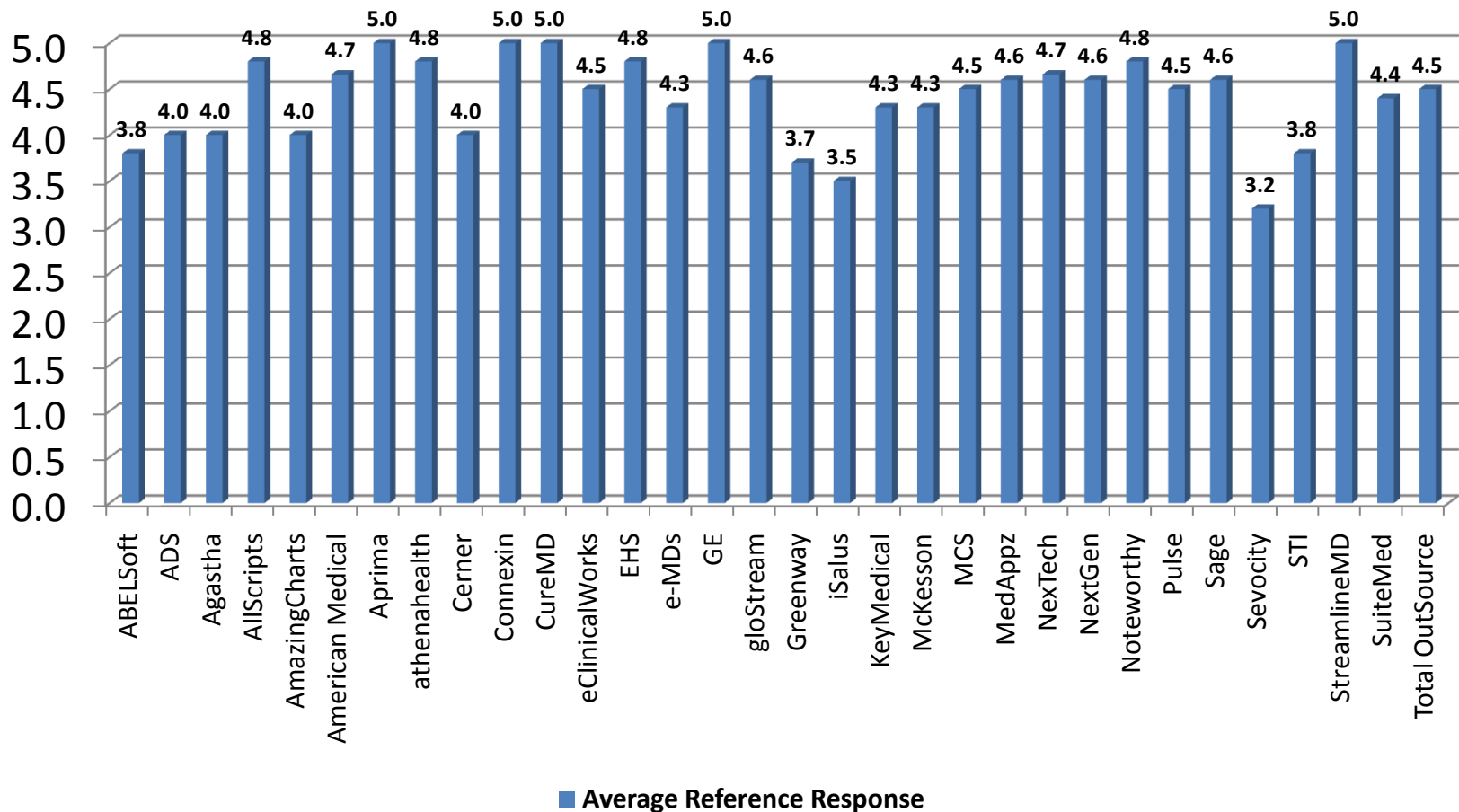
How would you rate your satisfaction with the EHRs ability to order tests and review results?

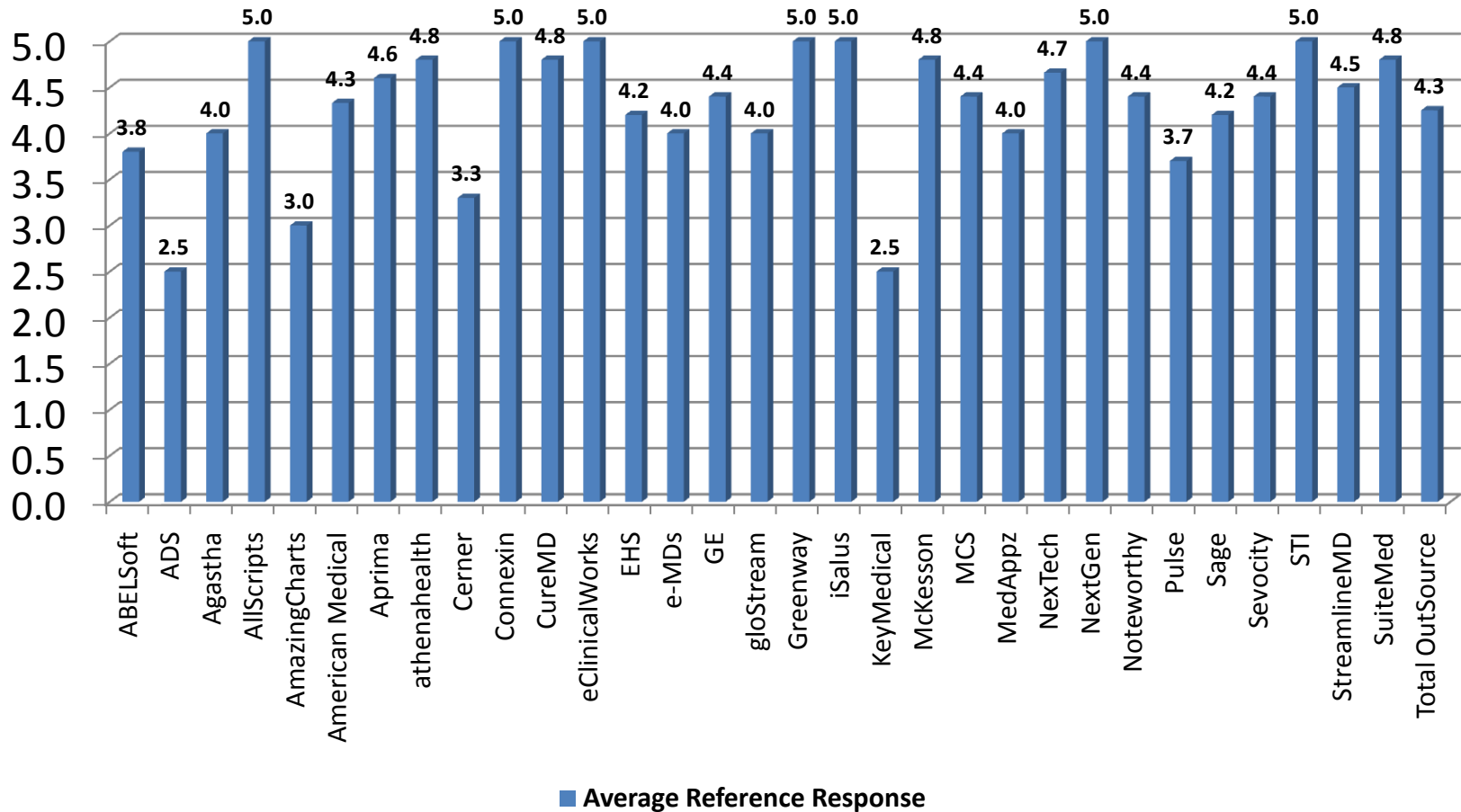
How would you rate your satisfaction with the EHRs ability to prescribe electronically?

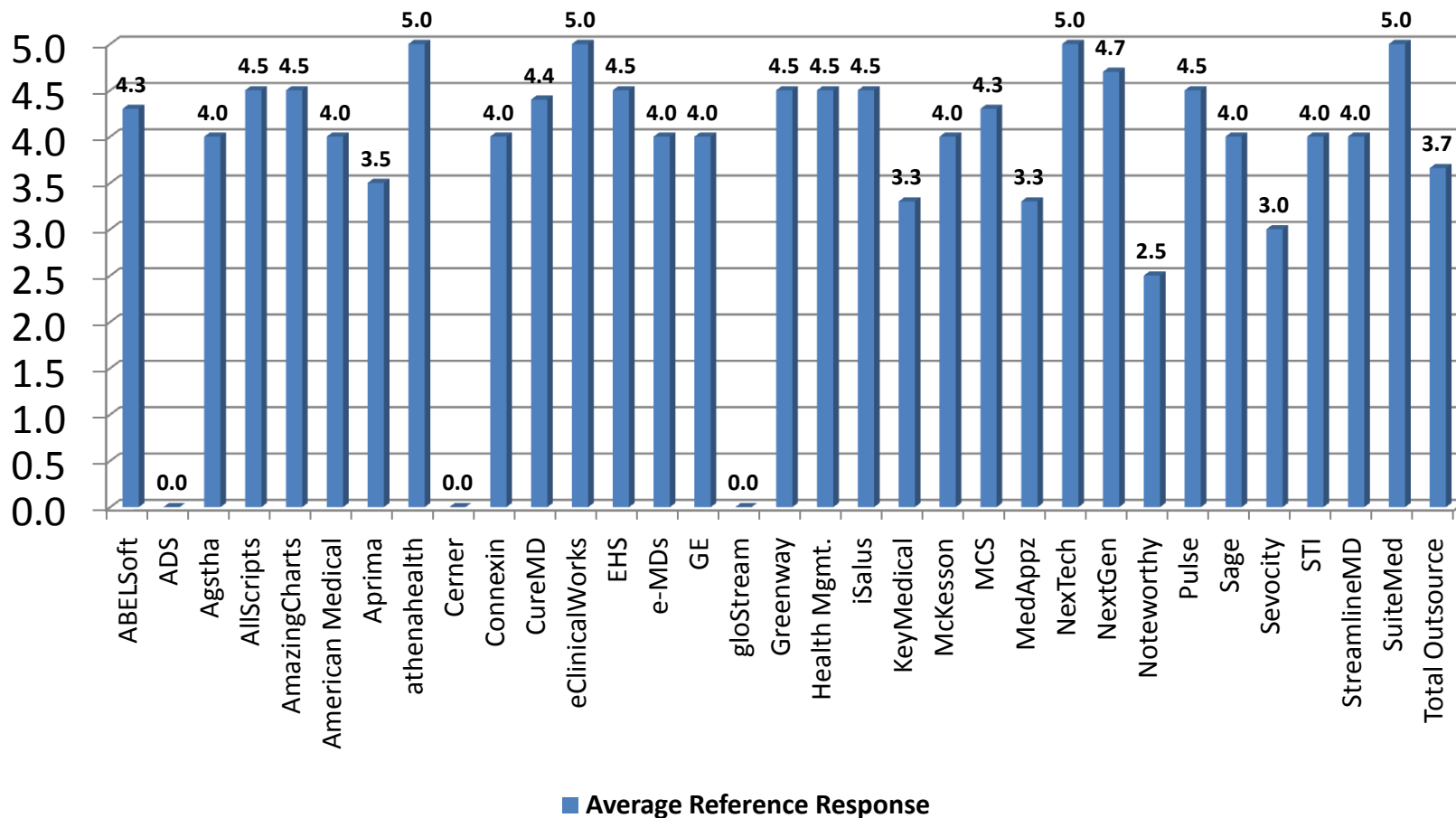

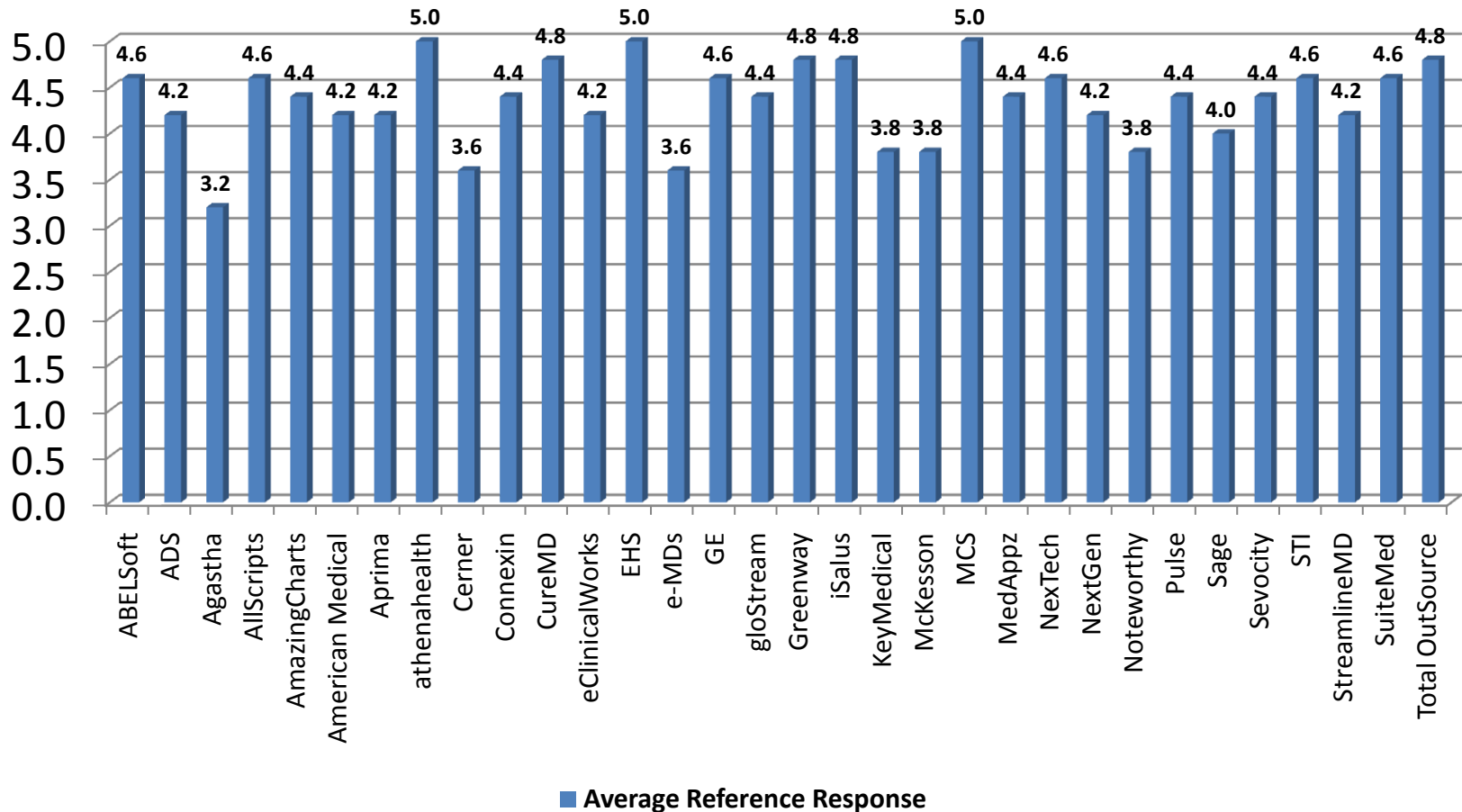

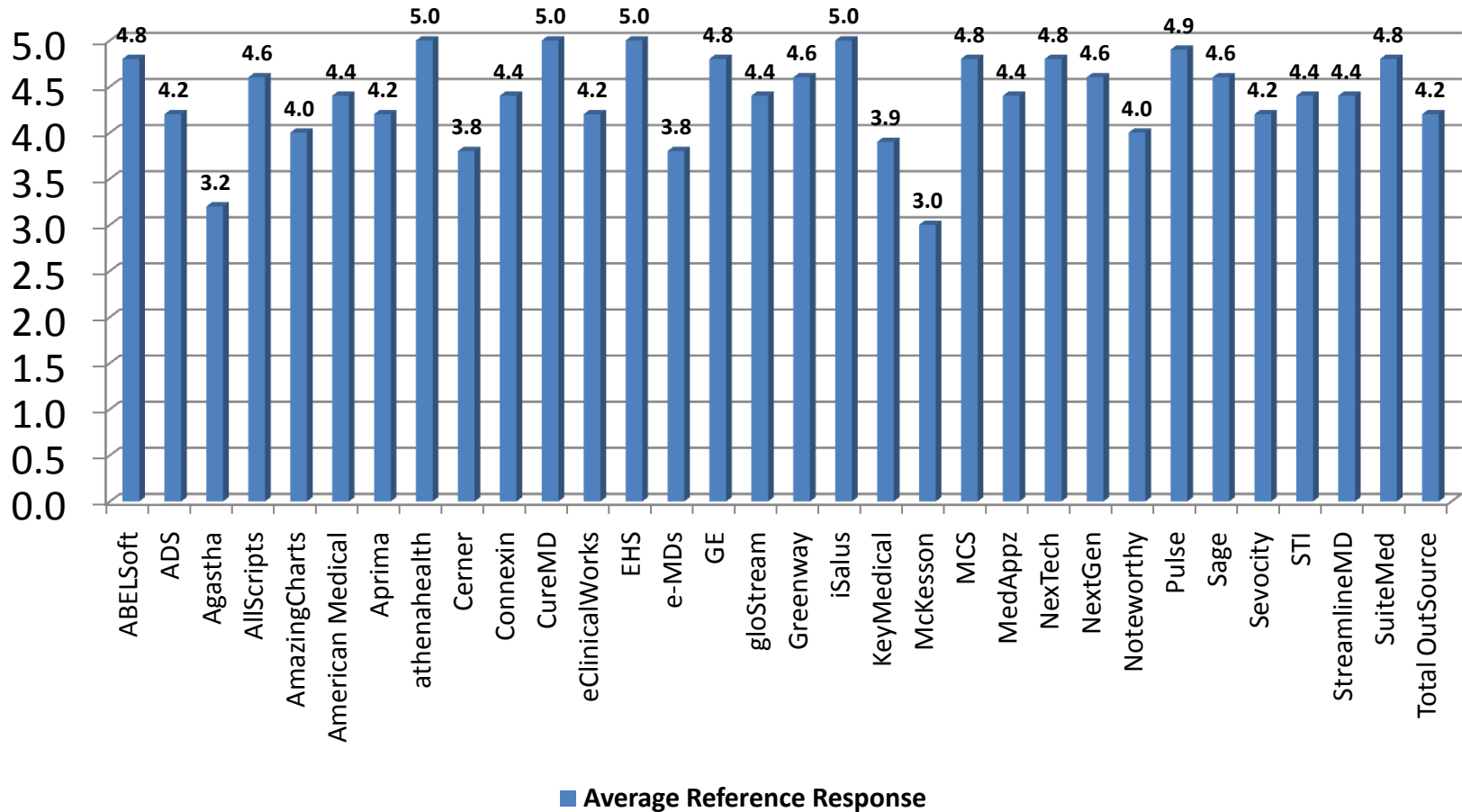
How would you rate the vendor on implementation?

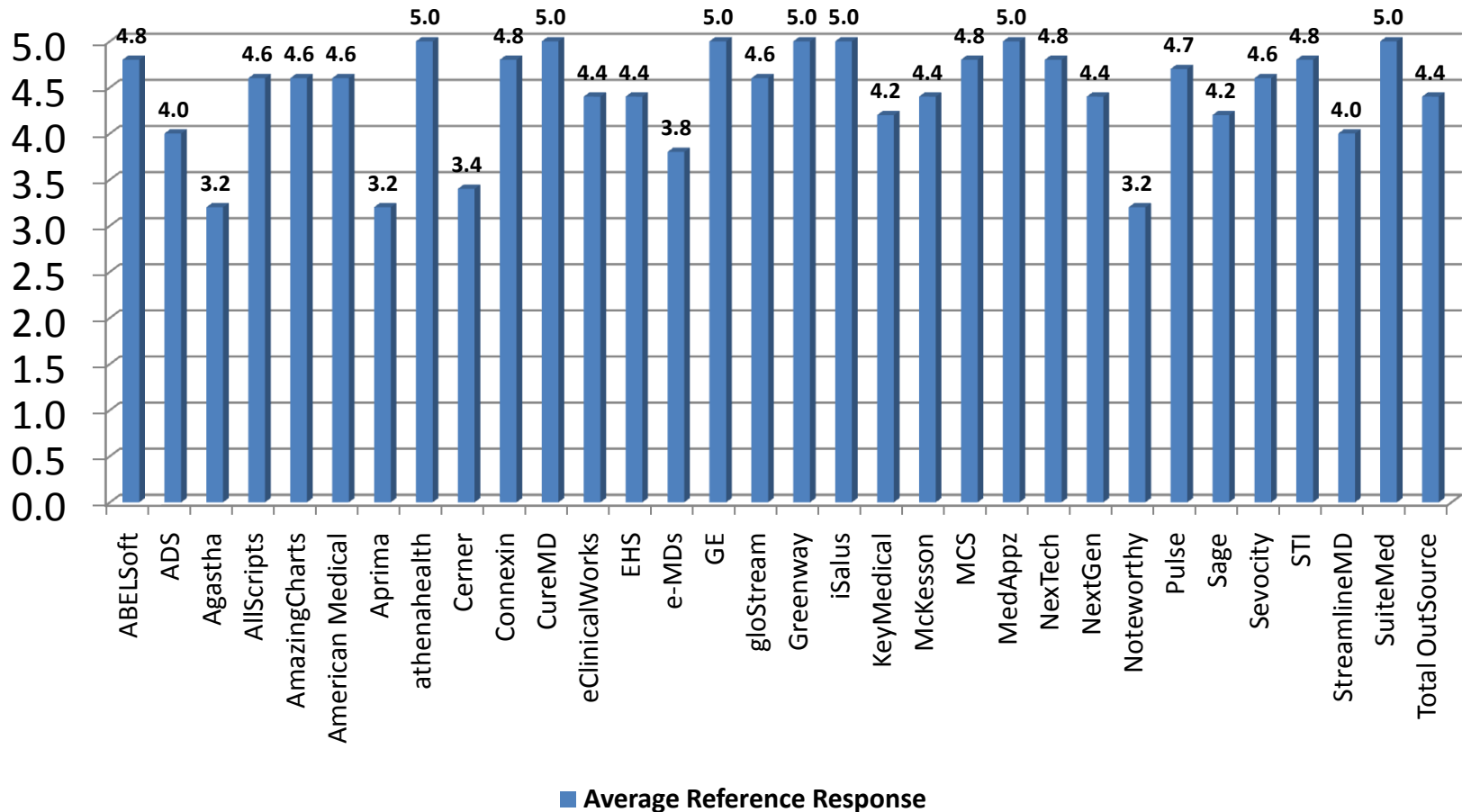
How would you rate the vendor on training?

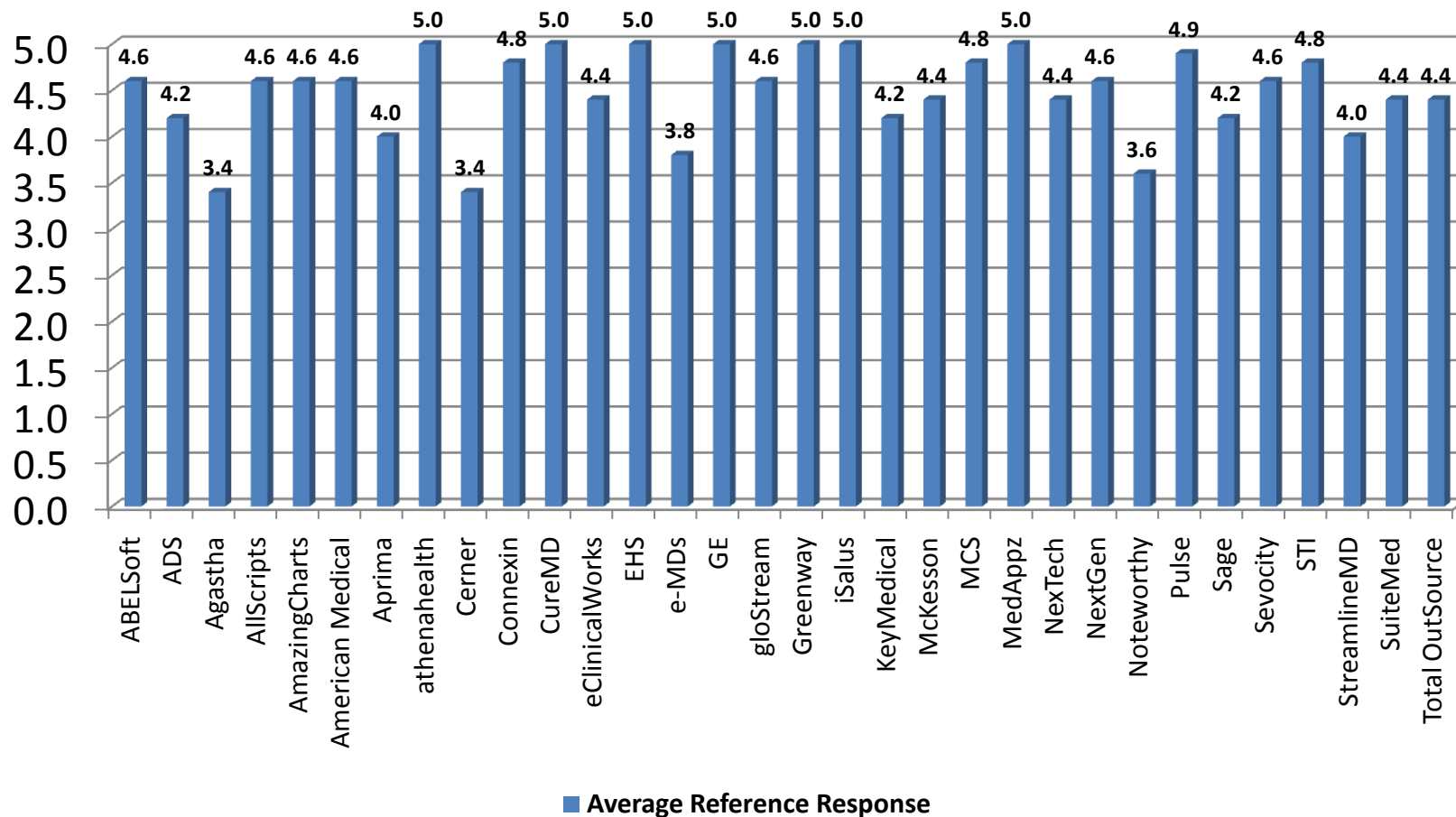
How would you rate the vendor on support?

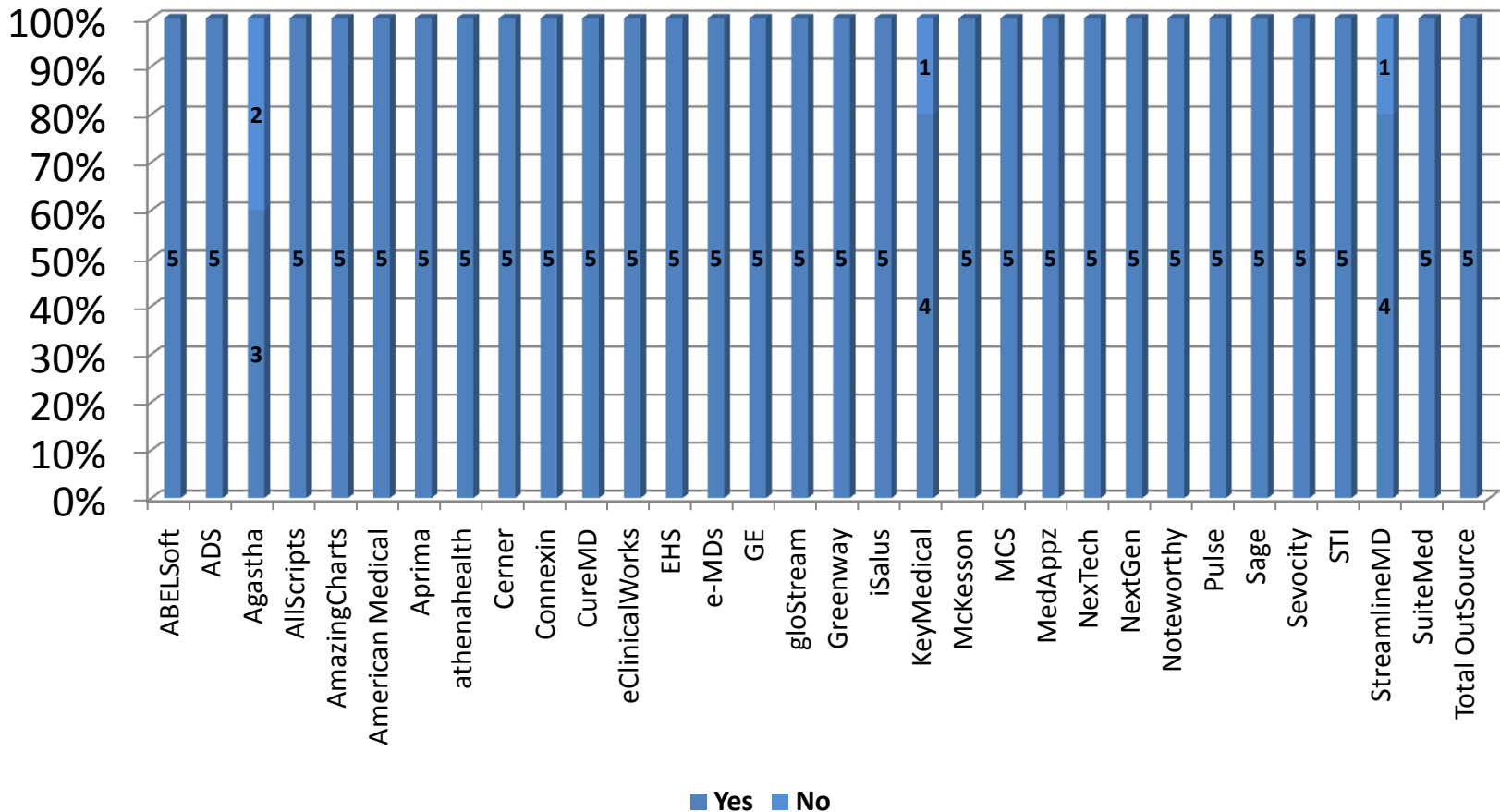
How would you rate the vendor on service?

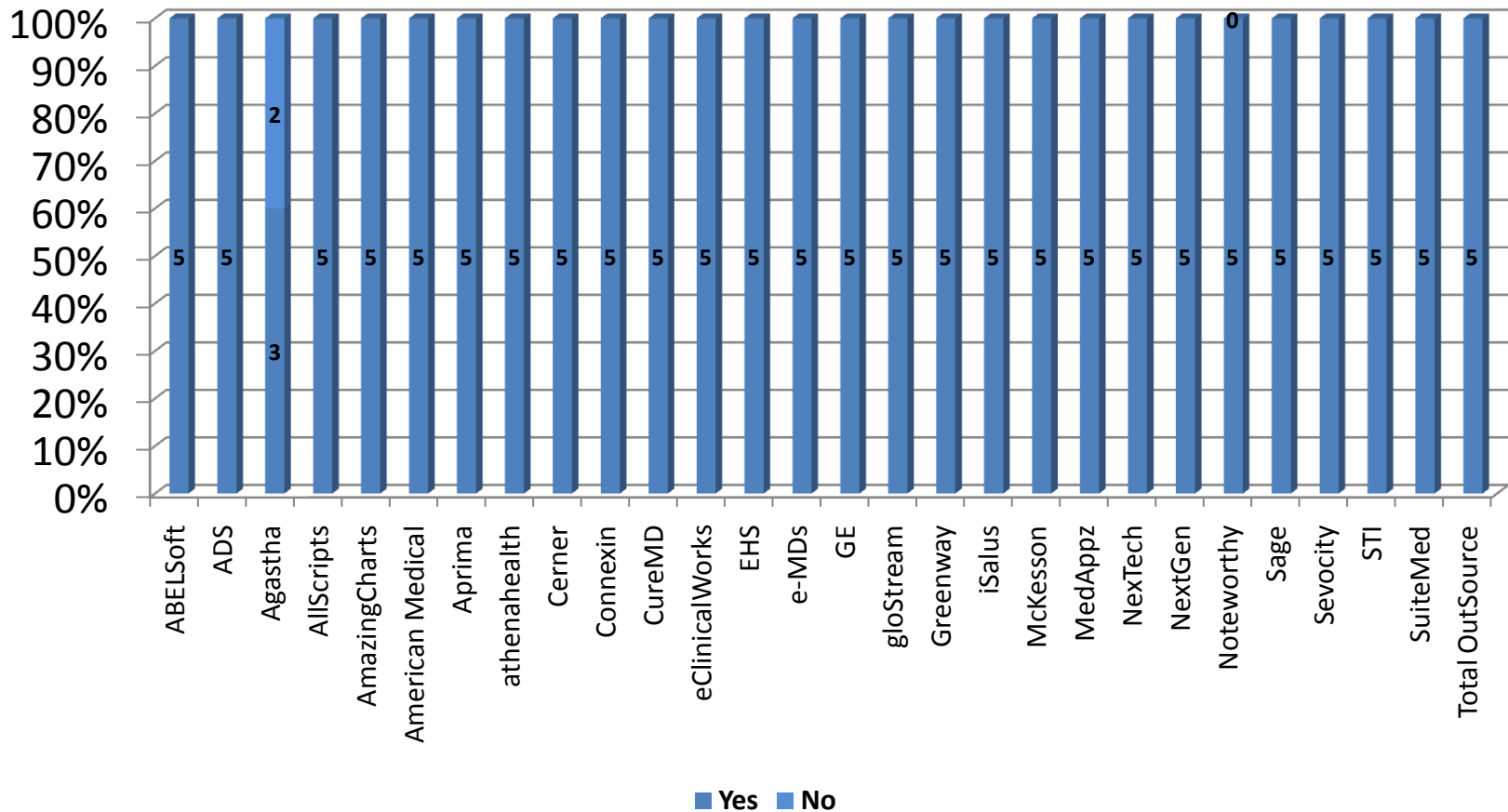
Would you purchase this system again?
